THE FOLLOWING MARKS ARE DESCRIBED RELATIVE TO THE RUNNING DIRECTION.

Start: Facing slightly NorthEast almost perfectly **INLINE** with the FH that resides between 172 & 176 East Shore Rd 9ft 6in **AFTER** Utility Pole 40032MNL -5610 819 298 (side #).

Mile 1: Facing Northeast in front of 124 Lake Dr 73ft 4in **AFTER** unmarked Utility Pole at house #130 AND 39ft 9in from the trailing edge of the sewer grate (same side, Fire Hydrant is between both) AND 50ft 1in **BEFORE** Utility Pole JC820MNL at the leading edge of the driveway at 120 Lake Dr.

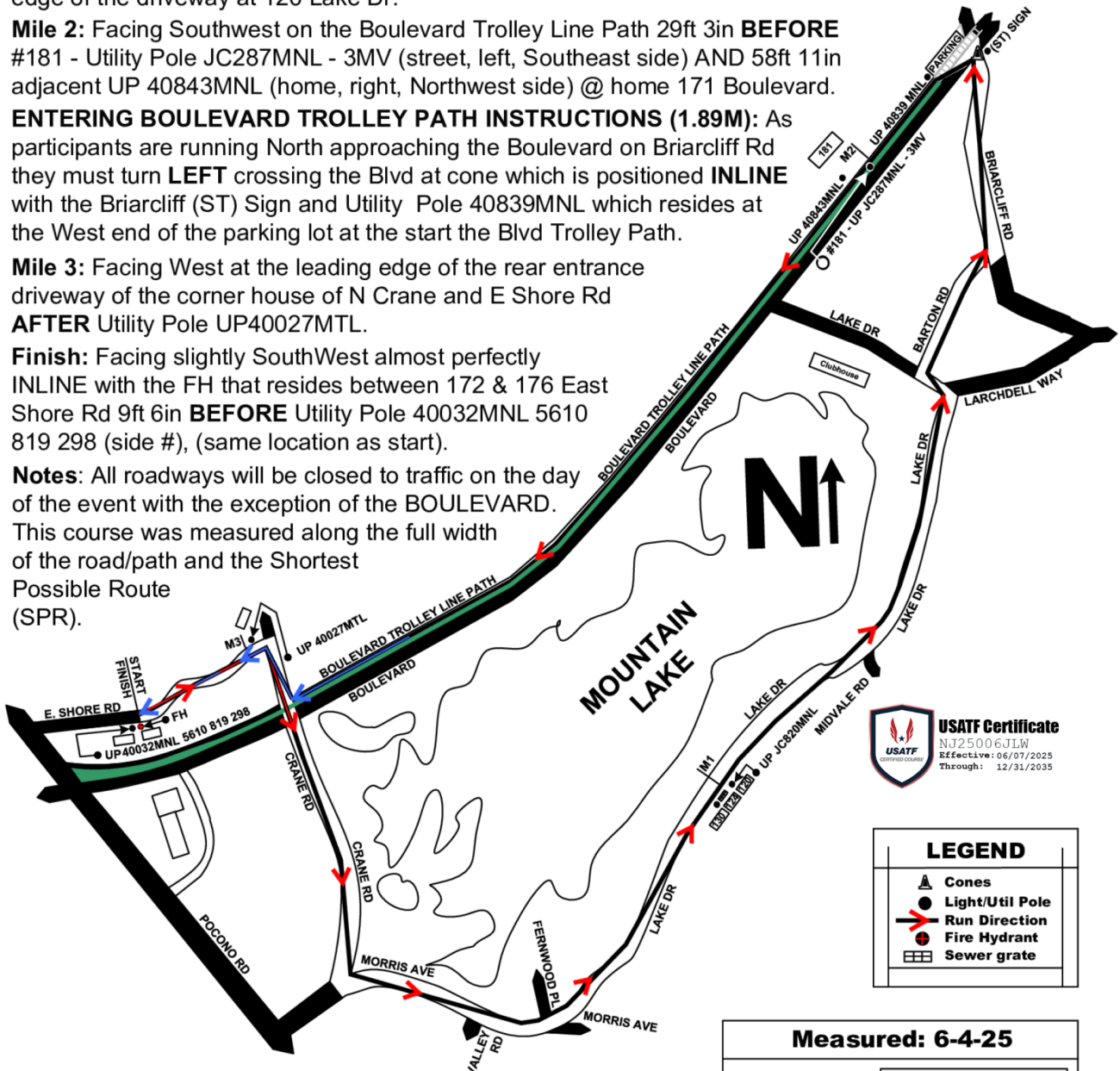
Mile 2: Facing Southwest on the Boulevard Trolley Line Path 29ft 3in **BEFORE** #181 - Utility Pole JC287MNL - 3MV (street, left, Southeast side) AND 58ft 11in adjacent UP 40843MNL (home, right, Northwest side) @ home 171 Boulevard.

ENTERING BOULEVARD TROLLEY PATH INSTRUCTIONS (1.89M): As participants are running North approaching the Boulevard on Briarcliff Rd they must turn **LEFT** crossing the Blvd at cone which is positioned **INLINE** with the Briarcliff (ST) Sign and Utility Pole 40839MNL which resides at the West end of the parking lot at the start the Blvd Trolley Path.

Mile 3: Facing West at the leading edge of the rear entrance driveway of the corner house of N Crane and E Shore Rd **AFTER** Utility Pole UP40027MTL.

Finish: Facing slightly SouthWest almost perfectly **INLINE** with the FH that resides between 172 & 176 East Shore Rd 9ft 6in **BEFORE** Utility Pole 40032MNL 5610 819 298 (side #), (same location as start).

Notes: All roadways will be closed to traffic on the day of the event with the exception of the BOULEVARD. This course was measured along the full width of the road/path and the Shortest Possible Route (SPR).
