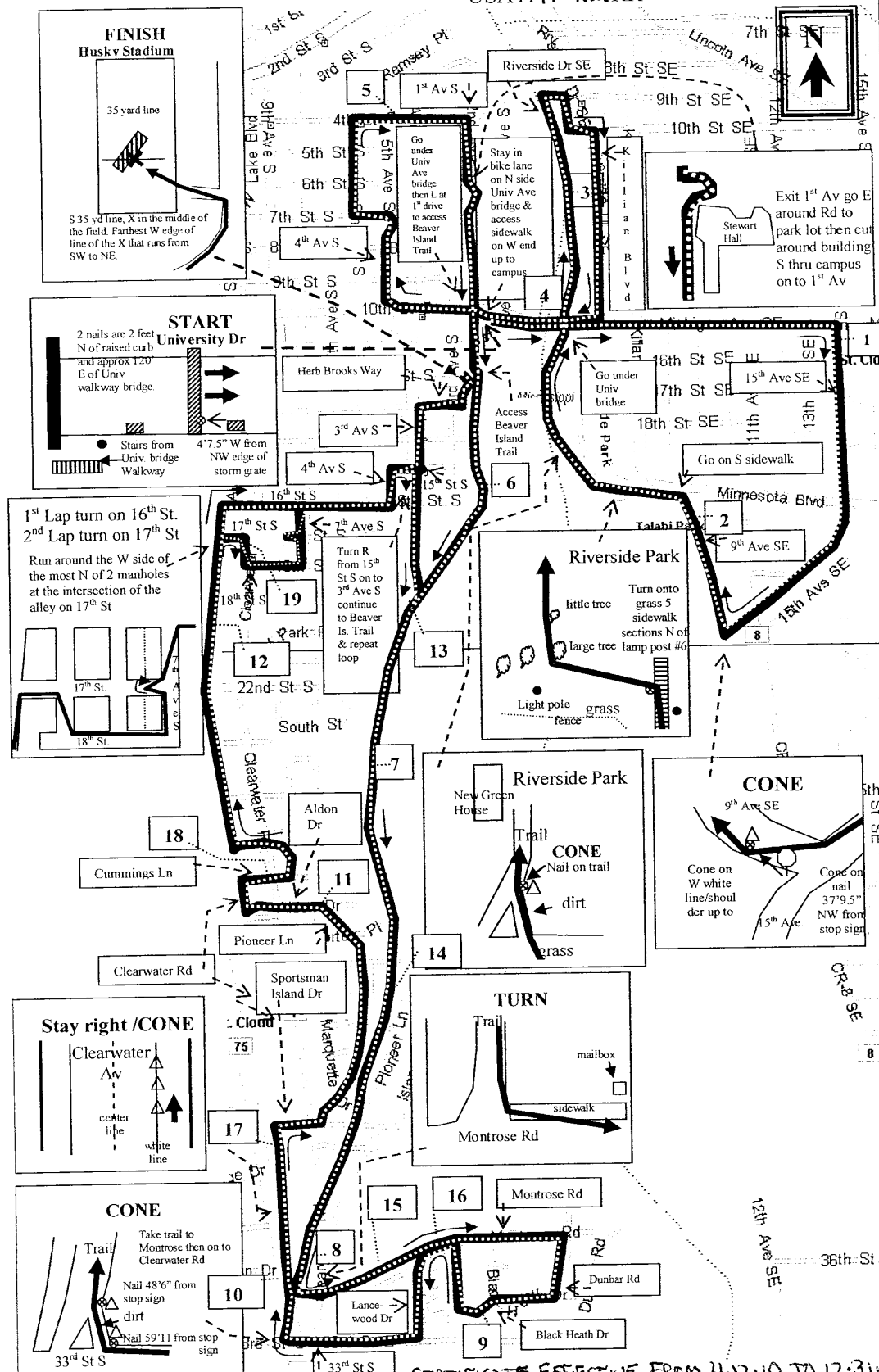


Earth Day 20 Mile, St. Cloud, MN

USATF MN 1020ERR



- MILE LOCATIONS:**
- 1 Mile:** On 15th Ave SE, W side of rd, 5th pavement divider section S of brick wall, S of house #1514
 - 2 Mile:** On 9th Ave S, W side, even with S end of porch of house #1926
 - 3 Mile:** On Riverside Dr, center of rd, just N of sidewalk of house #1220, even with S storm grate's N edge on W side of rd
 - 4 Mile:** E end of Univ Ave. bridge, N side, on road, but even with 4th concrete wall divider from the E going W
 - 5 Mile:** On 4th St S, just E of 4th Ave. E, S side of rd, 1st curb divider W of alley
 - 6 Mile:** On trail, approx 5' S of boat access, trail that is closer to parking lot
 - 7 Mile:** On trail, W edge, ESE of big steel high voltage tower in distance.
 - 8 Mile:** On trail, approx 200' before Montrose Rd
 - 9 Mile:** On Black Heath Dr., house #3144, at S entrance of the circle drive, not the drive going to the garage.
 - 10 Mile:** On the E side of Clearwater Rd, on the N edge of the N entrance of the Creative Memories parking lot.
 - 11 Mile:** Just off Pioneer lane, on S side of Aldon Dr. house #831, W side of the driveway.
 - 12 Mile:** On E side of Clearwater Rd, N of Park Place, between house #2006 & house #2012
 - 13 Mile:** just after the entrance to Beaver Island Trail & 23'10" N from base of "Welcome to Beaver Island Trail" sign
 - 14 Mile:** on Beaver Island Trail, wooden fence on L (east) between 4th & 5th fence posts N of walk way opening, & between 5th & 6th chain link fence on R (west) - count from N where fence jogs from W to S.
 - 15 Mile:** center of Montrose after Club View Ct., 9th curb pavement divider E of storm drain on N side of road.
 - 16 Mile:** S edge of Montrose, E of Golf Course crossing, 12'6" NE of manhole in grass
 - 17 Mile:** on Clearwater Rd, a few feet N of Golf View Ln, 25' WNW of fire hydrant
 - 18 Mile:** Cumming Ln, between #814 & #818, closer to #818
 - 19 Mile:** on 9th Ave S, just S of 17th St S, W side, 3rd curb pavement divider S of storm grate
 - 20 Mile / FINISH:** inside of stadium, S 35 yd line, X in the middle of the field. Farthest W edge of line of the X that runs from SW to NE.
