Start/Finish---On center median of Riverside Dr, the washer is 20'5" south of silver post with flashing traffic lights and 10'3" south of green Street light pole #82954.

Mile 1—On Front St near northeast corner at GE Patterson, the washer is 21'1" south of wood elec. pole #42467.

Control Turn #1— At end of yellow center stripe of GE Patterson west of 2nd St, the washer is 12' north of and 14'2" east of a water valve cover in the running lane.

Mile 2---On Main St approx. 60' south of Huling the washer is 1'2" south of the Trolley Stop structure.

Mile 3---On the north side of GE Patterson approx. 50' east of 2nd St, the washer is 4'6' west of pole #RY7463.
