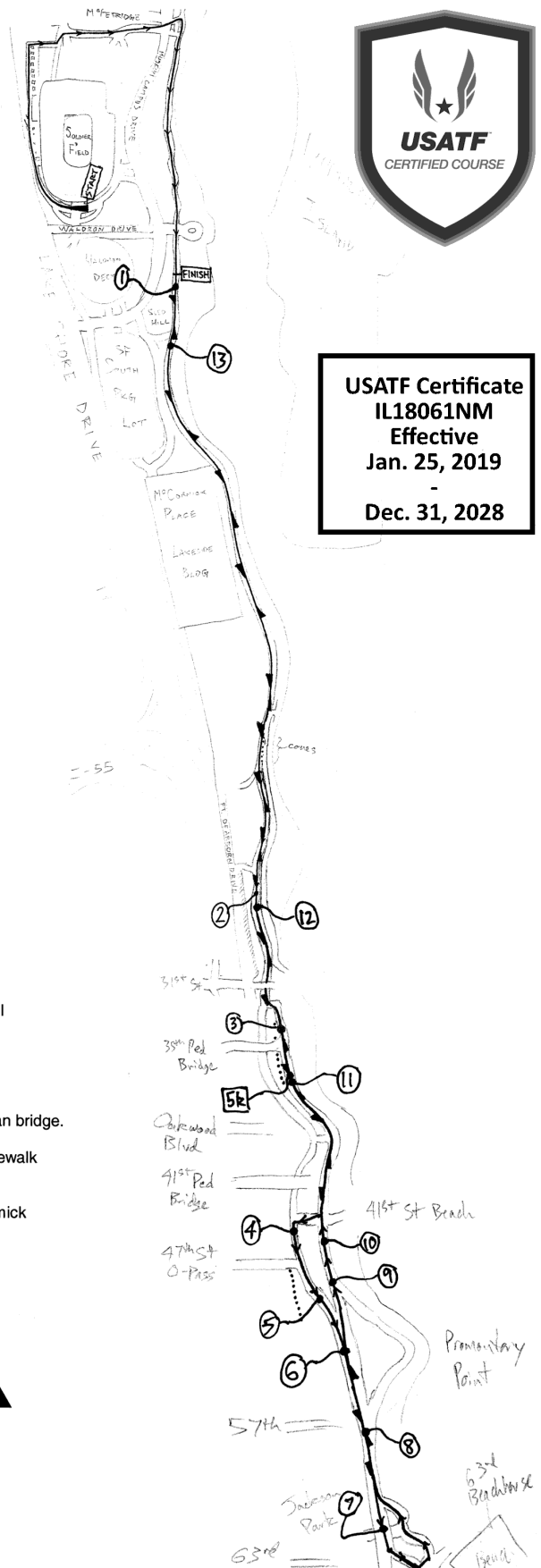

- START:** Soldier Field promenade, even with light pole that is between Door 2 & Door 0, 6 ft S of light pole.
- MILE 1:** Lakefront Trail bike path, 43.7 ft S of 3rd westside light pole that is S of Waldron Drive.
- MILE 2:** Lakefront Trail bike path, 12.5 ft S of 2nd light pole S of northernmost sidewalk leading to Ft. Dearborn angled parking area.
- MILE 3:** Lakefront Trail ped path, 9.6 ft S of 2nd light pole that is N of the 35th St pedestrian bridge.
- 5 km:** Lakefront Trail ped path, 7 ft S of 5th light pole that is S of 35th St pedestrian bridge.
- MILE 4:** Lakefront Trail bike path, 3 ft N of 1st light pole S of sidewalk to 41st St Beach.
- MILE 5:** Lakefront Trail bike path, 11 ft N of 8th light pole S of the 47th St pedestrian bridge.
- MILE 6:** Lakefront Trail path, 0.7 ft S of David Wallach Memorial Fountain at Promontory Point underpass.
- 10 km:** Lakefront Trail path, 85 ft N of LSD trafficlight pole at NE corner of intersection of LSD & 57th St.
- MILE 7:** Lakefront Trail path, 4 ft S of concrete/asphalt pavement seam at N end of 63rd St pedestrian underpass abutment...6 ft N of 6th light pole N of 63rd St.
- TA:** 63rd Beachhouse path, at light pole closest to NW corner of Beachhouse.
- MILE 8:** Lakefront Trail path, 18 ft N of LFT 2.5 Mile Marker sign.
- MILE 9:** Lakefront Trail ped path, 7 ft N of NE corner of painted restroom building.
- 15 km:** Lakefront Trail ped path, 12 ft S of 1st light pole S of S end of retaining wall at 47th St pedestrian overpass.
- MILE 10:** Lakefront Trail ped path, 1 ft N of 1st light pole S of path leading N of the Basketball court near 41st St Beach.
- MILE 11:** Lakefront Trail ped path, 6 ft N of 6th light pole that is S of 35th St pedestrian bridge.
- MILE 12:** Lakefront Trail bike path, 5 ft S of 2nd light pole N of 2nd-most northerly sidewalk leading to Ft. Dearborn angled parking area.
- 20 km:** Lakefront Trail bike path, 9 ft N of old drinking fountain that is S of McCormick Place Bird Sanctuary stone path.
- MILE 13:** Lakefront Trail bike path, 25.6 ft S of light pole that is S of the Sledding Hill.
- FINISH:** Lakefront Trail bike path, 65.5 ft S of the 2nd westside light pole that is S of Waldron Drive.
