

START: At light pole between door #22 and door #23 at Chaska H.S.

1 Mile: At the west edge of the Pioneer Park West sign on trail 2 Mile: Directly between doors #8 and #9 at the middle school

Turnaround: 86ft 6in W. of 4<sup>th</sup> no parking sign W. of H.S. on Purple Brick Rd.

3 Mile: 15ft E. of E. edge of fence on trail at Purple Brick Rd.

Finish: At first joint in curb S. of purple and yellow Hawks bench near door #32
