### Key Points

**Described as race is run.** Course is a point-to-point route run from east to west. Wood post mile splits not adjusted for remeasurement.

**Start** On Culver Ave facing SW. Line is 85'1" from middle of traffic control pole at NE corner of Beech Grove Pl.

**Mile 1** On Culver Ave at NW corner of Welsh Bush Rd, 11' before traffic control pole.

**Mile 2** On R side of Pleasant St, 2'6" before dlw for #1105.

**Turn Point Cone** On Memorial Pkwy before Valley View Rd intersection. Point is in CL between light poles #345 on N and #344 on S.

**Mile 3** On R side of Valley View Rd, 8' before pole #7-331.

**5 km** On R side of Valley View Rd, 82'3" after pole #331 NM 9 on R and 20'7" before pole NM #106 | Bell Atl #14 on L.

**Mile 4** On L side of Steele Hill Rd 14'6" after third stone bridge and before overlook on R.

**Mile 5** On R side of Memorial Pkwy EBL in intersection with Elm St. Point is 74' before SE face of Statue of Liberty in median.

**Mile 6** On R side of Burrstone Rd before entrance of Rtes 8N and 5E. Point is 40' after walkway to residences #910/908.

**10 km** On Burrstone Rd 14' before median break for exit from York St.

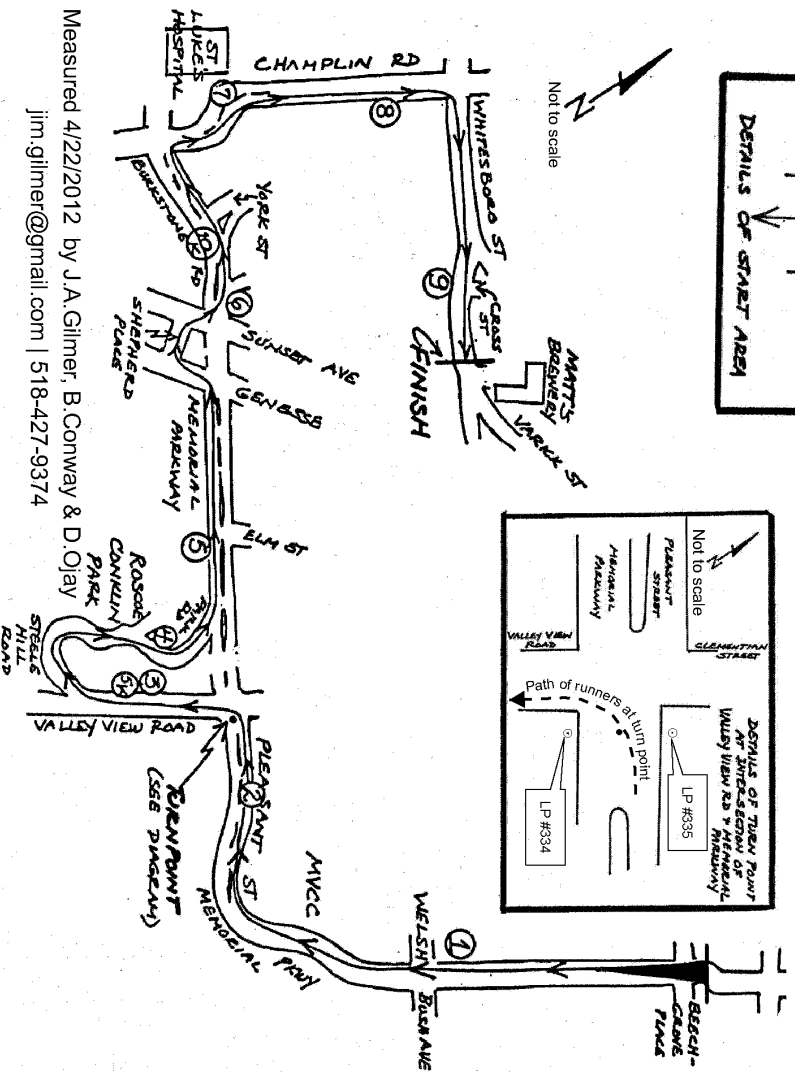
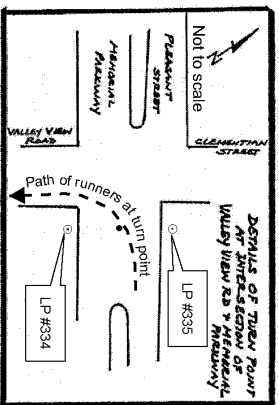
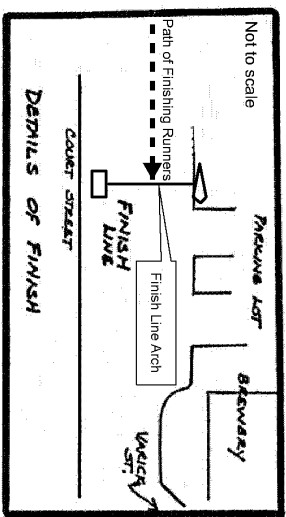
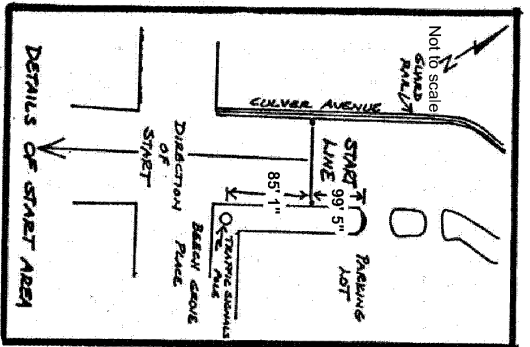
**Mile 7** On R side of NBL for Champlain Ave, 90' before median break to St. Luke's Hospital entrance.

**Mile 8** On R side of Champlain Ave, 6" after walkway to #1003 residence

**Mile 9** On R side of Court St, 33' after hydrant opposite Cross St intersection.

**Finish** On Court St, in middle of permanent arch marking "Finish Line of Boilermaker Road Race."

**Marked with mag nail and orange paint.**
