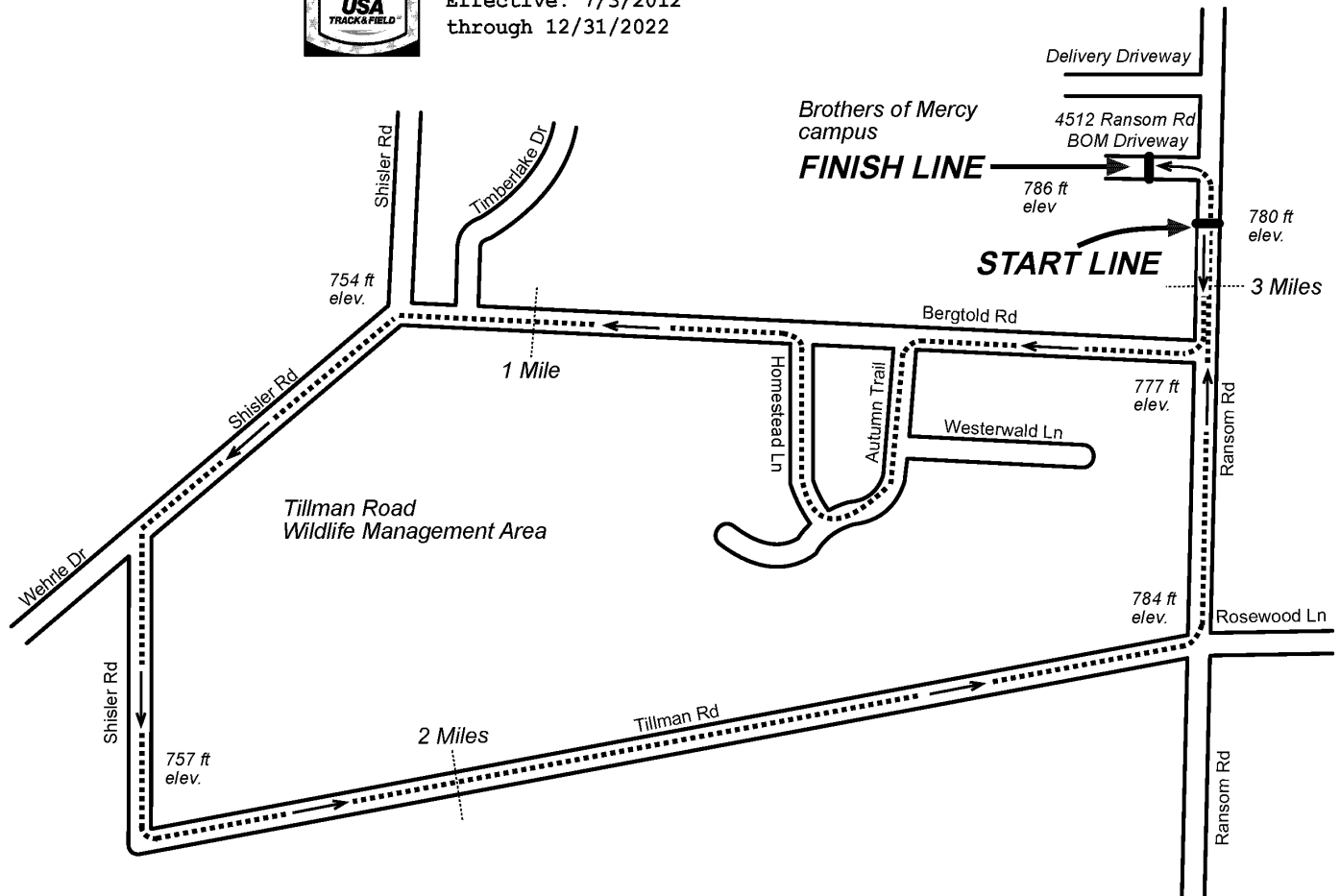

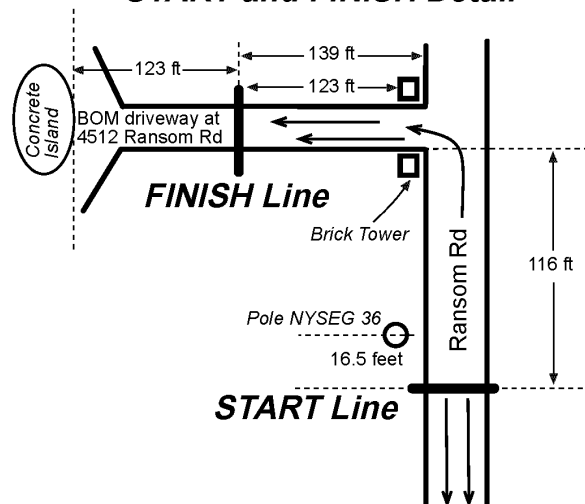

## Mile Splits

- START** On Ransom Rd, 112 ft south of the BOM driveway and 16' 5" past pole NYSEG 36.
- 1 Mile** Near 10320 Bergtold Rd, 19 feet past fire hydrant on south side of road and east of intersect with Shisler Rd.
- 2 Miles** On Tillman Rd, in the swamp section, no viable permanent physical markers nearby. about 516 meters past Shisler Rd
- 3 Miles** On Ransom Rd, 59 feet before pole NYSEG 367 / 39, near 4435 Ransom Rd
- FINISH** Midway on the BOM Driveway at 4512 Ransom Rd, 123 feet east of the concrete island and 139' west of Ransom.
