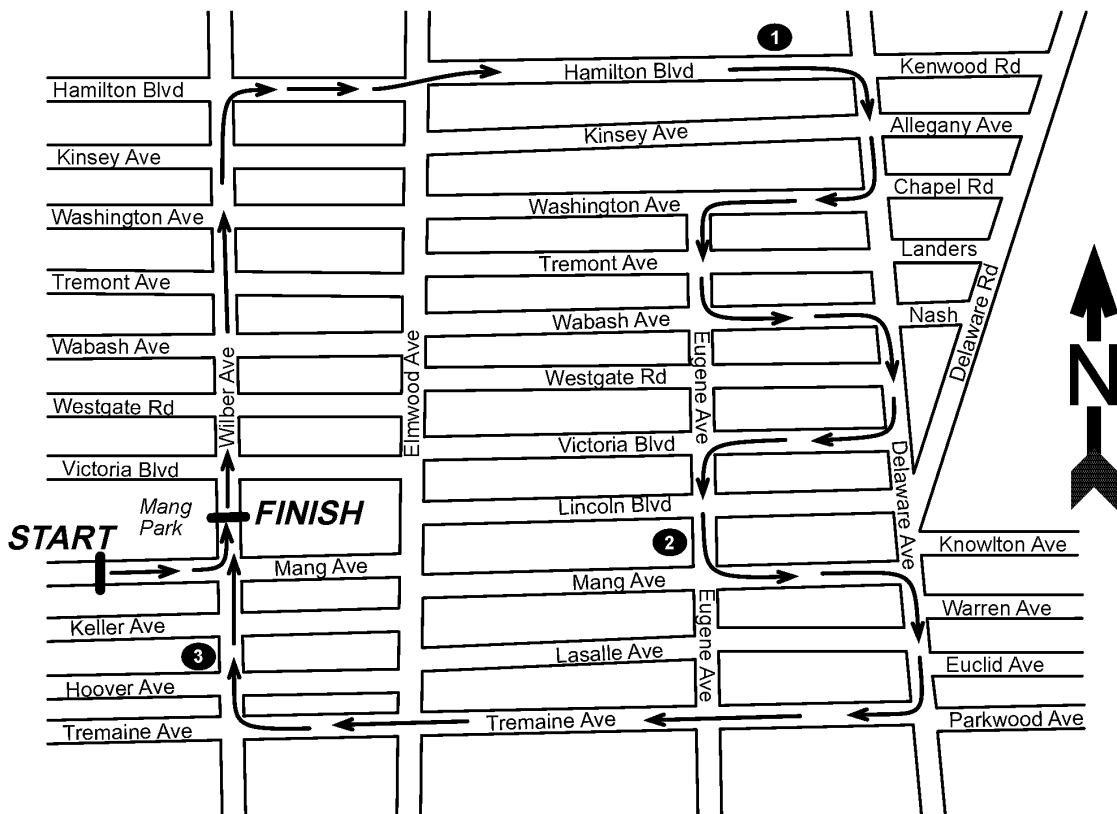

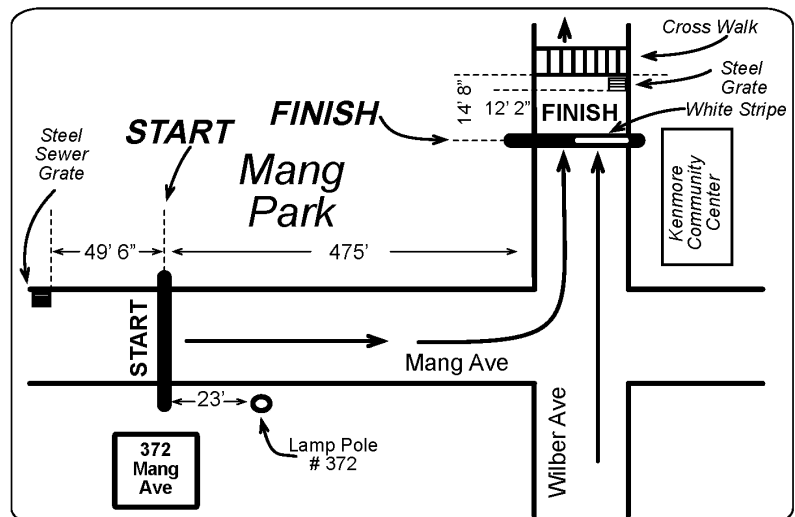

Mile Splits

- START** 372 Mang Ave, and 49' 6" east of the steel sewer grate (on N side of road), and 23' west of Lamp Pole # 372.
- 1 MILE** 46 Hamilton Blvd, at Lamp Pole # 35, (160 yards west of Delaware Ave).
- 2 MILE** On Eugene Ave between Mang Ave and Lincoln Blvd, and exactly at Pole # NG217.
- 3 MILE** On Wilber Ave between Keller Ave and Hoover Ave, and 25' north of Pole NG87.
- FINISH** On Wilber Ave at the north end of the Kenmore Community Center bldg, and exactly at the big White Stripe that is 14' 8" south of the Cross-Walk, and 12' 2" south of the steel grate (grate on east side of road).
