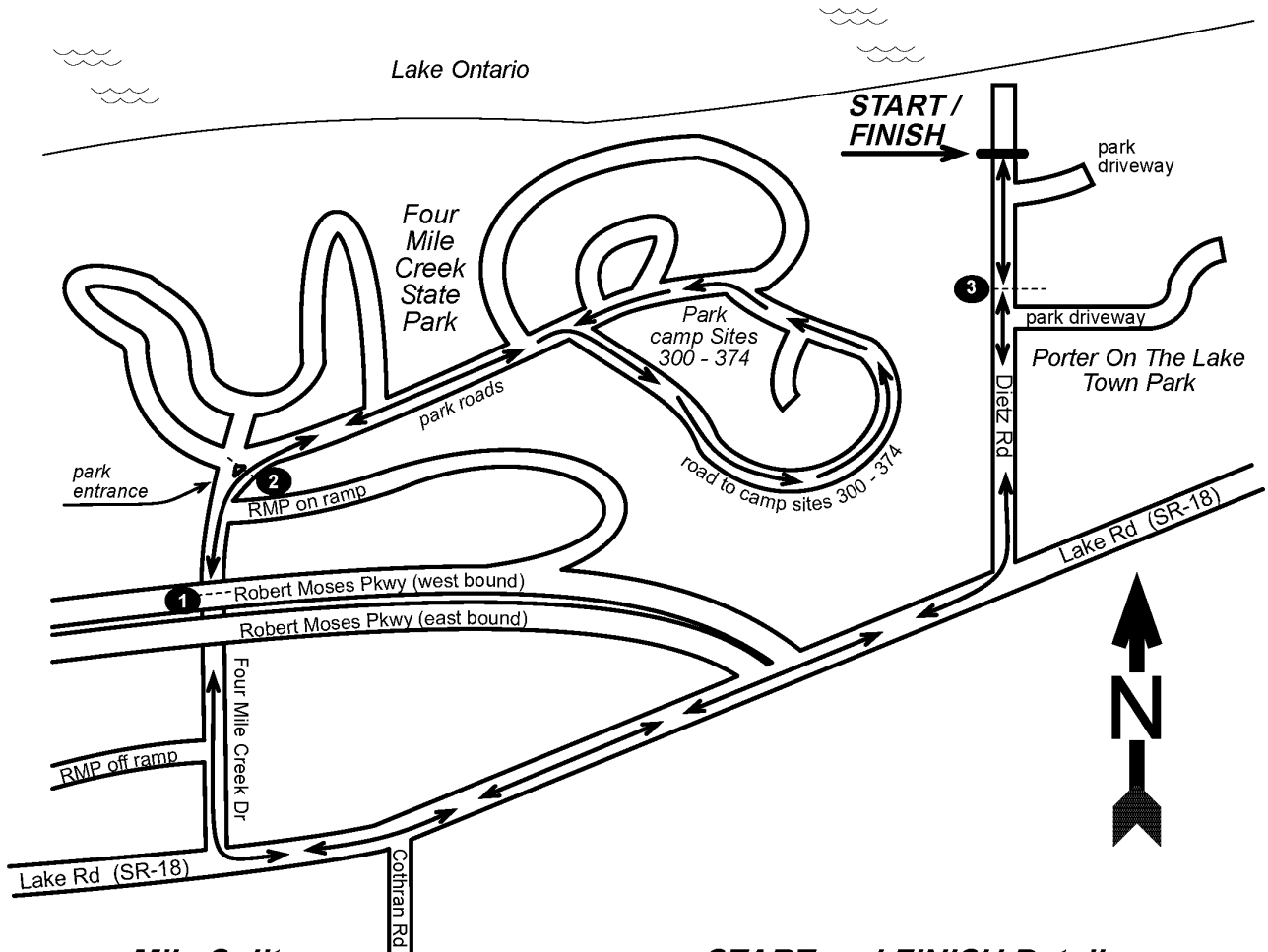

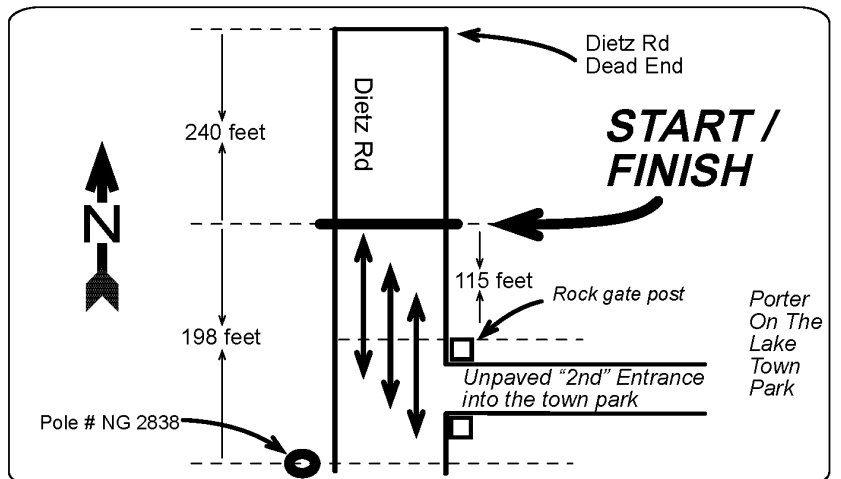

Mile Splits

- START** On Dietz Road, 198 feet north of Pole # NG 2838, and 115 feet north of the northern gate post of the northern entrance into Porter On The Lake Town Park, and 240 feet south of the northern terminus (dead end) of Dietz Rd.
- 1 MILE** On Four Mile Creek Rd, at the center of the westbound overpass of the Robert Moses State Pkwy.
- 2 MILE** In the Four Mile Creek Park exactly 75 feet before the exit/entrance gate.
- 3 MILE** On Dietz Rd 40 feet past (north of) Pole # NG 2892 and 80 feet past Porter On The Lake Park main entrance.
- FINISH** Same as start location.
