

330 Broad. It is also 17' SE of sign for "Village Square."

- 1: 4'N.E. of telephone pole A 82 SPP 635 in front of 609 Smith Ave. (gas station).
  2: 11'10" N.E. of Fire hydrant on corner of Smith and Farm Ave.
- (across From "Mom and Dad's" parking lot at 1800 Smith)
- 18' S.E. of the large pine next to the pond in the yard of 2111 Pinetree.
- at Front door of 2412 Patterson.
- 5: the S.W. edge of the house at 1311 Clay.
- 6: the N.E. edge of the house at 220 Clay.

Finish: On Broad St. in Front of Post Office at light pole #406. It's also 54' NW of flag pole in Front of Post Office.
