Start/Finish: On Krause St, directly in line with the center of the double doors on the south side of the Delaware County Courthouse. Also located 13 m east of the east edge of the museum on Krause St.

1K/4k: On 5th St, 9 m south of the street signs at the intersection of 5th St (CR 608 Rd) and S 610 Rd. (36.4121 -94.7492)

2k/3k: On 5th St, 26.6 m north of the start of the guardrail for the bridge over Brush Creek. (GPS 36.4121 -94.7942)

Turnaround: On 5th St, 24.2 m north of the telephone box on the east side of the road that is labeled "1G 24". (GPS 36.4014 -94.7955)
