Start & Finish: near the middle of Farr Road; edge of easterly building projected to south side of Farr Road; 96' east of fire hydrant; 71' west of electric transformer #86952 @21 Farr Road.

Mile 6: #112 Cochran Road (CR); 2' west of the hedge/property line between #112 and #124; 52' west of utility pole #120367

1K & 9K: CR; 114' west of utility pole #81443; just east of St. Mary's cemetery; 32' east of large culvert; also marked on guardrail

Mile 1: #910 CR; driveway to Cochran's Ski Area; 71' east of front door of house; 112' east of utility pole #81153

Mile 5: east of #1090CR; 50' west of utility pole #81558; also marked on guardrail

2K & 8K: CR; 103' east of utility pole #81158; 153' east of mile 5; also marked on guardrail

3K & 7K: CR; middle of nowhere; near clump of large (>24") Cottonwood trees on south side of road; 23' east of centerline of north side of rec parking area

Mile 2: CR; 65' east of centerline of parking lot entrance

Mile 4: #2374 CR; 69' east of west corner of large horse pasture at Juniper Knoll Farm; 99' east of horse rider caution sign

4K & 6K: #2374 CR; 7' east of west edge of large barn at Juniper Knoll Farm; 51' east of mailbox; just east of easterly driveway to farm; west of Grey Stone Drive

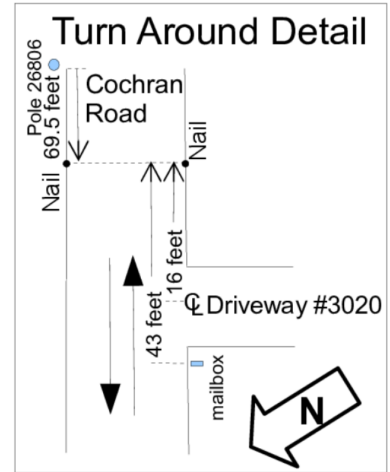
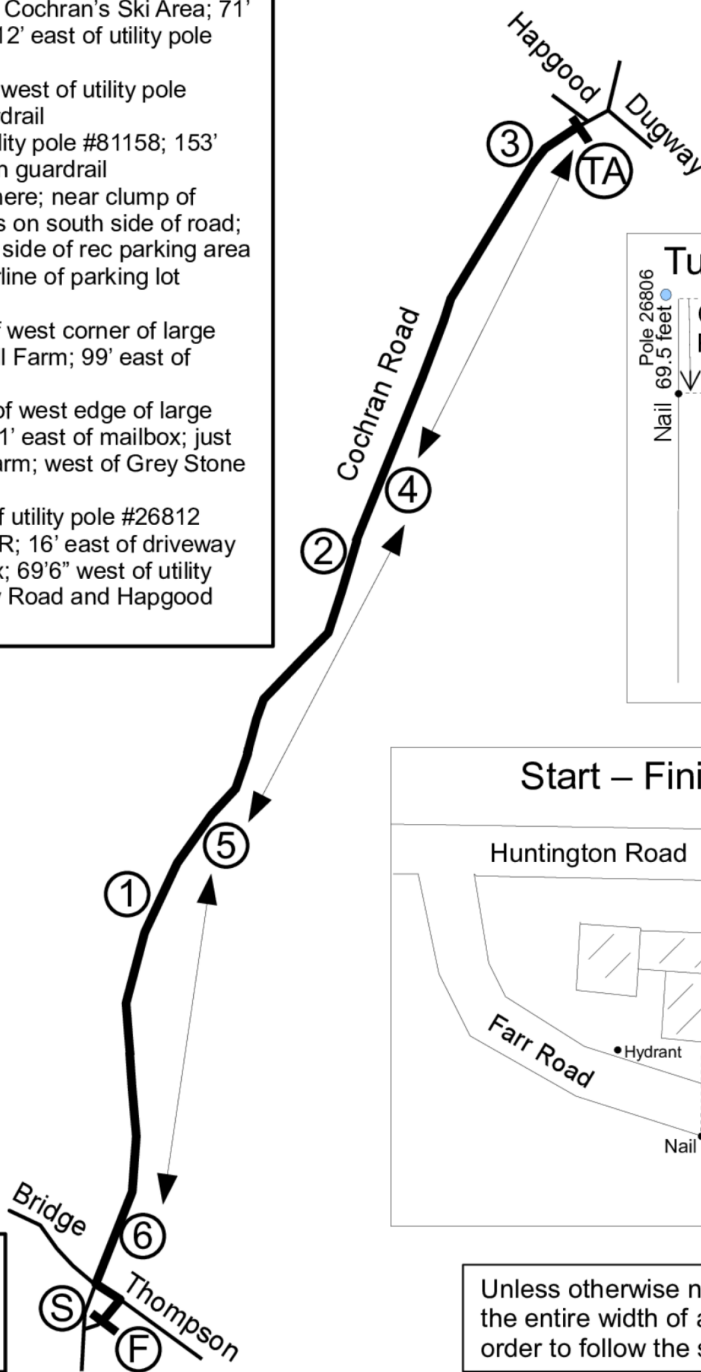
Mile 3: #2944 CR; 25' west of utility pole #26812

5K & Turn Around: #3022 CR; 16' east of driveway centerline; 43' east of mailbox; 69'6" west of utility pole #26806; west of Dugway Road and Hapgood Lane
